- 1. Rufiji District Council has received funds from Development Partners and the Government of the United Republic of Tanzania toward the cost of Procurement of Drilling Contractor for Conducting Geophysical Survey, and Drilling of Productive Boreholes for Water Supply in Ten (10) villages of Rufiji District Council, and intends to apply portion of the funds to eligible payments under the Contract for which this Invitation for Bids is issued.
- 2. The Rufiji District Council now invites sealed bids from eligible and qualified Drilling Contractors to carry out Geophysical Survey, Drilling, pumping test and development of productive boreholes for Tawi (2), Siasa (1), Nambunju (2), Nyawanje (1), Kungurwe (1), Namakono (1), Ruwe(1), Nyaminywili (1), Mkongo (1) and Chumbi (2) in Rufiji District Council.
- 3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the Public Procurement Act, 2011 and the Public Procurement (Goods, Works, Non-Consultant Services and Disposal of Public Assets by Tender) regulations 2013 and are open to all bidders with class Two (2) and above.
- 4. Interested eligible bidders may obtain further information from and inspect the tendering documents at the office of the **District Executive Director**, **Rufiji District Council**, **P.O. BOX 28**, **Rufiji**, from **7:30am to 3:30 pm Monday to Friday inclusive except on Public Holidays**
- 5. Qualifications requirements include: Legal status (including registration with the Ministry of Water and Irrigation and CRB) of the bidder, proposed major equipments for carrying out

the drilling works, qualifications and experience of key personnel for administration and execution of the contract, proposed sub Contractors and firm involved (if any) and financial status of the bidder.

- 6. A complete set of Bidding Documents in English, in hard copy and additional sets may be purchased by any interested bidder on address given on paragraph 5 above and upon payment of a non refundable fee of Tanzania shillings One Hundred Thousands only (Tshs. 100,000.00) or its equivalent. Payment should be made either by bankers draft, banker's cheque, or cash to the District Director, Rufiji District Council, P.O. Box 28, Rufiji.
- 7. All tenders in one original plus three copies, properly filled in, and enclosed shall be submitted at or before 11.00 A.M on Wednesday 19th April, 2017. Late bids will be rejected. Bids will be opened physically in the presence of the bidders' representatives who choose to attend in person at the Conference Room, Rufiji District Council
- 8. Bids shall be valid for a period of ninety (90) days after Bid opening and must be accompanied by a Bid Security of Two (2) Percent of bid price in Tanzania Shillings or its equivalent in a convertible currency and shall be delivered to District Executive Directors office, Rufiji District Council on or before 11.00 a.m hours local time on Wednesday 19th April, 2017, at which time they will be opened in the presence of the bidders who wish to attend.
- 9. Payment will be made only to the successful (Productive) Boreholes. It should be noted that, late tenders, portion of tenders, electronic tender, tender not received, tender not opened and not read out in public at the tender opening ceremony shall not be accepted for evaluation irrespective of their circumstances.
